Minutes of the 61st (2024) Annual General Meeting

The minutes of the 61st AGM were proposed for acceptance by Jenny Bourne and seconded by Chris Drayson and approved unanimously. There were no matters arising.

Chairman's Report

The Chairman read his report as follows:

I have to first apologise for not being able to attend the AGM last year when I was elected Chairman. Thank you for electing me. It was always going to be difficult following on from Mark Merrington's successful 10 years and I am grateful to him for the support that he has given me.

I am delighted to say that our membership numbers this year are even better than last year. It is great that we have such involvement from the Hampton Wick community. In addition to being Vice Chair and various other roles I need to thank Mark Merrington for all the work he puts in as Membership Secretary.

As for events, we have had:

- The AGM itself with, I am told, a very successful *Unusual Wine Quiz*. I hope that this year's *French & German* themed event will be just as much enjoyed.
- Our first Treasure Hunt this was aimed at providing fun and also at helping participants to *Discover Hampton Wick*. Even some of us who have lived here for many years learned some new things. The very positive reaction from those who took part has meant that there will be another Treasure Hunt this year. My thanks to Mark

Buckley and Carol Dukes and an absolute army of volunteers for all the hours of work that they put in to organising the event and then running it.

- Library display which consisted of photographs showing several of our shops in the 1970's and their appearance now.
- Remembrance Sunday we again participated in this important community event and provided the marshals to ensure the safety of the procession to the Remembrance Garden and during the service. Thanks to Jem Negus and his team of volunteer marshals and to the others who helped by organising the temporary road closure and in setting up the Remembrance garden.
- The Christmas carols evening As usual, this began with story-telling in Bullen Hall for the children and mulled wine and mince pies for the adults, then a procession down to St John's Place where, with the accompaniment of the Richmond Brass Band, everyone joined in the carols. And, of course, Father Christmas came along, giving presents to many excited children. Thanks to the committee members for their input into this with particular thanks to Margaret O'Connor for all her work on the children's presents. Thanks also to Richmond Council, who had helped prepare for the event by replacing the rather sad yew tree with a healthy-looking Christmas fir. As usual, we also decorated the village with small trees on wall brackets, festooned with lights, on the buildings. I am grateful to all the HWA volunteers who arranged this and ensured that everything worked.
- We did not participate in a much slimmed-down Chestnut Sunday that centred around D-Day celebrations. A larger event is being prepared for this year and we have been invited to get involved once more. We will be there.

Our campaigning work continued with:

- Discussions with Richmond Council on the proposals for the area around St John's Place. This went to consultation and plans were drawn up that now await financial allocation before finalisation.
- Some good input on the business side from David Tall, of Estate & Agent. Unfortunately he has now had to step back a bit because of pressure of work.
- Planning issues, as always, played a significant role in our work with Nick Baylis playing the major role. We need to thank him for his knowledge and experience in this sector as well as the work he puts in. Among the major issues of interest were: the former Kelly's Dance Studio where there have been continuing concerns over the build differing from the approved plans; Sainsbury's, now open, where planning permission was not required apart from for signage and licencing hours and where we requested a change to the proposed signage to make it more appropriate to the High Street; and Kingston Bridge House, where we had discussions with the proposed developers in advance of a public consultation. The outcome on this building remains uncertain. I can update you that the developers have invited us to a further meeting at which they will show us their latest proposals and we will of course report back after that.

I need to again thank all the editorial contributors and distributors – again all volunteers – who make our Magazine possible. Issues in March and October were very well received and a new magazine will come out shortly. Also on the paper-based side of our communications, we continue to maintain our three notice boards. We also have our electronic communications including the website, e-mail news, and the \mathbf{X} (formerly Twitter) account. We have however now switched from \mathbf{X} to Bluesky as we believe that to be more appropriate. I am grateful to our new member, Carole Reniero, who has volunteered to help with our social media output. As a result, we have recently opened accounts on Facebook and Instagram.

We decided that it would be good to find out a bit more of what our membership and others thought about the Association so organised an online survey. This achieved a very good response with general agreement that we were concentrating on the right issues. There were some useful suggestions that the committee are following up on. For example, we have added some new committee roles. And we very much welcomed offers to volunteer. Fear not, we are following up on these too.

I am most grateful to the committee members for all the work that they have put in over the past year. I should mention in particular Annie Murray and David Tall (who was co-opted on) for their very valuable input as they have decided that they must take a step back for the present and have therefore decided not to stand again.

We are looking forward to another year of events and activities and I am very heartened by the interest that is being shown by you, our members. Thank you.

Information was also sought on the latest position regarding Kingston Bridge House.

Nick Baylis reported that not much had changed although it was expected that there would be an application for a hotel with approximately 90 rooms and additional residential accommodation. It was expected that there would be a public consultation/exhibition by the developers (Westcombe) followed by the formal submission of a revised planning application.

An update was sought on last year's parking consultation.

Cllr Millard replied that he expected Council letters to be sent to residents imminently.

Jenny Bourne proposed a vote of thanks to the committee.

An attendee told the meeting about forthcoming screenings of short films on the theme of peace.

Peter Buckley queried the three large and unsightly bollards placed in front of the driveway of one of the cottages on Sandy Lane.

No-one was sure but it was felt that the change had come about following the passing of the previous resident.

Liz Tapp reminded the meeting that Bullen Hall is now a great local facility and encouraged everyone to use it more.

Iain Burgess commented on how nice the Twinning flags in the hall were.
